Message From the President -

President's Annual Report – Deborah Graham

On behalf of my fellow Board members, welcome to our Annual General Meeting.

As we have stated before, we are sure Anduhyaun's original Grandmothers, Vera Martin, Mildred Redmond, Mary Jane Young and Jeannette Lavell, and signatories of our Letters Patent, March 121h1973, would be pleased that our circle continues to remain strong. The strong circle is evident in Cathy Pawis and Wanda Whitebird both of whom have shared their wisdom and experience as volunteer Board members since 2005. Thank you Cathy and Wanda for your generosity of spirit.

The Greater Toronto Area's, GTA, lack of permanent affordable housing is an ongoing Client concern, especially when waiting lists can be 5 years or more. We are pleased to report that our second stage housing's occupancy rate is approximately 71%, and that we assisted 26 Clients in acquiring permanent housing this year.

You will also see from Steve Silverberg's, Auditor's report, our efforts to remain within budget have proven to be modestly successful.

Thank you to the Ministry of Community and Social Services (MCSS), Toronto Social Housing Unit (TSHU), and Homelessness Partnership Initiative (HPI), for the administrative support and funding. We extend special thanks and gratitude to those who have donated time, items and finances this past year; to name a few, Unifor 112, the Rotary Club of Etobicoke and Basketeers.

It has been a busy year for our dedicated 7 member Fundraising Committee. Our objectives were to increase our fundraising efforts through events and partnerships. For example, in the spring, we partnered with Vesey's Seeds and raised a modest sum through the sale of garden bulbs. Also, we held two fundraising events, one, our first Annual Strawberry Moon Fundraiser; second, an online Winter Campaign, for both events we raised \$9,818.35. In March of this year, we hosted a donor appreciation evening, Friends of Anduhyaun, for our donors and sponsors.

A special thanks to our Executive Director, Blanche Meawassige for her continued efforts to secure a new shelter. For the upcoming year, we will continue our fundraising efforts and our quest for a new shelter.

We hope you will join us in our efforts to raise awareness and bringing an end to Gender-Based Violence, Murder and Missing Indigenous Women, Human Trafficking and violence against children.

Executive Director's Report – Blanche Meawassige

To Anduhyaun's donors and funders we appreciate your ongoing support, notably, Ministry of Community Social Services (MCSS), Homelessness Partnering Strategy (HPS), Miziwe Biik Aboriginal Employment and Training; Toronto Social Housing Unit (TSHU), The Rotary Club of Etobicoke; Unifor 112; and Indigenous and Northern Affairs Canada (INAC).

In 2016, Ontario (MCSS) launched a strategy to end human trafficking. Later, MCSS partnered with the Ontario Native Women's Association to establish the Indigenous Anti-Human Trafficking Liaisons and requested a call for proposals, to which Anduhyaun responded and was successful. For the remainder of 2018, Anduhyaun will conduct a feasibility study led by coteam leaders Bonnie Johnston and Tsitra McKay. Bonnie and Tsitra will engage the community to assess the need for wrap-around services.

With the financial support of HPS and the City of Toronto, a number of minor capital upgrades and purchases were completed, such as:

- Nekenaan has a fully accessible unit and is AODA compliant
- Replacement of small appliances
- Re-pavement of driveway

In addition to the above, HPS also supported Anduhyaun in providing culturally appropriate programming. Programming that holds fast to Anduhyaun's belief that Traditional healing and knowledge is not only a way of life but path that is fundamental to one's life journey.

To the Board of Directors, thank you for bringing your passion, intellect, insight, experience and resources to the table. To staff for their service and dedication to those we serve. Finally to my colleagues, thank you for sharing your gift of humour, experience and kindness.

This past year, we said farewell to Cathi Porciello and Pamela Hart and thank them for their service. At the same time, we welcomed Amber LaForme, Transitional Support Coordinator, TSC, to the team.

Shelter Annual Report - Lisa Powell

This past fiscal year the shelter have serviced 157 women and 64 children within the Shelter. This past Fiscal we saw that women were staying longer and working on their care plans while we offered a safe and secure place to reside while gaining resources and counselling. We also recognized an increase in the amount of children that was serviced as well as their length of stay, which has become longer. Of the 157 women served 16 were successful in securing permanent housing. The Outreach programs have jointly serviced 349 women and 13 children.

We have had the great honour of having special invited out of town elders/ grandmother's and teachers provide circles and ceremony to our women and children thus providing an opportunity to reconnect with one's culture.

During the past year we have had the pleasure of experiencing compassion and generosity of many, including the students from Humber College in Professor Peter Dawson's classes. These students have started to work to raise awareness about the barriers our Indigenous women and children face. This new set of students from Humber College, have donated supplies, toiletries and food items

We would like to acknowledge the Etobicoke Rotary Club and the group Basketeers, for their continued commitment to our Clients by way of donations. Anduhyaun Shelter would also like to thank the Ministry of Community & Social Services for their continued funding and support, City Hall for their kind support through the Shoebox Project, which provided personalized gifts at Christmas. We would also like to include and acknowledge all the individual kindness from various community members that have gave back to us in some way and their continued support through donations and awareness sharing.

Nekenaan Second Stage Housing Annual Report – Robin Chenevert-Keays

The past fiscal year has once again been very rewarding and busy here at Nekenaan. Over the past year we have maintained an occupancy rate of 71%. We welcomed 10 new households and helped 10 families move from Nekenaan to permanent and or affordable housing. At the end of our fiscal year, March 31, 2018 we had a total 18 families occupying 22 units with a 75% occupancy rate and no arrears.

There have been several improvements here at Nekenaan. With support from the Homelessness Partnering Strategy (HPS), high powered fans and new microwaves for all the units were purchased. With a grant from HPS we also repaved the driveway, adding a more accessible front entrance and walk way. We replaced all toilets, renovated the main office, the 61h floor offices, the basement activity room, and kitchen with new flooring, and a fresh coat of paint.

One major improvement we were able to achieve this year, is our new accessible unit. Thanks to the generous grant we received from the City of Toronto, we were able to renovate one of our current units into an accessible unit. This unit can accommodate a woman and a child. It includes a brand new bathroom, mobility beds, specially designed kitchen and furniture for clients with accessibility needs. This will only enhance our ability to provide more options to women fleeing violence and who need this accommodation.

With the addition of the Housing Administrator Assistant position, our ability to assist the new and existing clients has greatly increased. Nekenaan's successes and growth will always be reflected best in the lives of the women and children who come to live here. As we continue to grow and change, there will be challenges to face, but, we will become stronger and wiser because of them. I look forward to working together with our Nekenaan staff, to continue to provide support to the women and children who access our services.

Transitional Support Coordinator Annual Report – Amber LaForme

I am fairly new here at Anduhyaun as the Transitional Support Coordinator (TSC), and I would like to take this time to introduce myself. My name is Amber LaForme and I hail all the way from the Six Nations reserve. I am of both Mohawk and Seneca Nations and of the Turtle clan. I am very pleased to have joined the Anduhyaun team.

The TSC strives to meet Anduhyaun's mandate, and with this focus, there has been ongoing growth this year in programming and tenant supports.

Programming has continued focusing on traditional teachings from Traditional Teachers/Elders. Other programming has included healthy eating community cooking, free general admissions to the ROM, onsite food bank and an onsite clothing bank. New initiatives include a resource room with computer access for the tenants, and a Housing Support worker coming from Wigwamen Inc monthly to Nekenaan.

Continuing partnerships and relationships are with Anishnawbe Health Toronto, FoodShare, Barbra Schlifer Clinic for Women, Wigwamen Inc, Kids Up Front, Brands for Canada, The Stop Community, Aboriginal Legal Services of Toronto, Royal Ontario Museum, Aboriginal Services of CAMH, Aboriginal Housing Support Centre, the Mount Dennis community centre and Native Women's Resource Centre (NWRC).

Continuing to be a primary focus is developing working relationships and partnerships with anyone who can assist with accessing permanent housing for the tenants of Nekenaan. I am currently working on developing a partnership with Council Fire's housing program.

The next year is anticipated with optimism and excitement. There is much gratitude and appreciation for the direction and support of Anduhyaun's Executive Director, Blanche Meawassige, and the Board of Directors. Along with a passionate dedicated management team whom I have the honour to work with, I look forward to the next year.

This past year there have been a number of changes, including the Homelessness Partnering Strategy (HPS). HPS was a unique community-based program aimed at preventing and reducing homelessness by providing direct support and funding to communities including Anduhyaun, for which are appreciative. Today, we are now working with Reaching Home: Canada's Homelessness Strategy (formally HPS) which was designed to support the goals of the National Housing Strategy.

To Anduhyaun's donors and funders we appreciate your ongoing support, notably, (formerly) Ministry of Community Social Services (MCSS), Homelessness Partnering Strategy (HPS); Toronto Social Housing Unit (TSHU), The Rotary Club of Etobicoke; Unifor 112; and Indigenous and Northern Affairs Canada (INAC).

Last year's report spoke to our success in obtaining funds from The Human Trafficking Strategy, MCSS, to conduct a study. Since, Bonnie Johnston and Tsitra McKay completed the study which looked at the need for wrap-around services. Our project was called Nanda. Loosely translated from Anishnaabemowin, Nanda means 'to look or to search.' There are a number of key findings. In particular, it was found that the current shelter structure does not work for many people who are trying to exit human trafficking. As a result, it was recommended that the shelter services and a housing services be delivered separately and based on best practices and promotes 'social inclusion.'

With the financial support of HPS, some minor capital upgrades and purchases were completed, such as:

- Activity Room, Nekenaan
- Accessible doors

In addition to the above, we are grateful for HPS financial support so that culturally appropriate programming continues.

To the Board of Directors, thank you for bringing your passion, intellect, insight, experience and resources to the table. To staff for their service and dedication to those we serve. Finally to my colleagues, milgwetch for your continued support, good food and sharing your gift of humour.

Last but not least, I would like to take this opportunity to acknowledge Jannies Le for her dedication and hard work this past year and extend warm wishes to her as she goes on Maternity Leave.

During the upcoming year, we will continue to work diligently in our pursuit of a new shelter and continue to provide optimal service to those we serve.

This past fiscal year the shelter have serviced 243 women and 34 children. We offered a safe and secure place to reside while attending counselling, accessing external resources and participating in internal workshops and presentations. Of the 243 women served 101 were Indigenous. The Outreach program serviced 239 women and children.

Anduhyaun Shelter would also like to thank the Ministry of Community, Children & Social Services for their continued guidance, direction, funding and support. As well as all of their support guidance and perseverance in our efforts to secure a new shelter. We would also like to include and acknowledge all the individual kindness from various community members that have given back to us in some way and their continued support through donations and awareness sharing. We have been fortunate this year to be able to purchase a new refrigerator and stove, as well as new mattresses and cribs for all of the bedrooms and new computer systems for the staff to complete their work on.

We are all very excited with the anticipation of the new shelter in the coming years and look forward to new growth and change along the way.

Annual Meeting – July 4, 2019 Robin Chenevert-Keays, Housing Administrator

It has been another amazing and busy fiscal year at Nekenaan. Over the past year, we have maintained an occupancy rate of 90%. We welcomed 11 new households and helped 8 families move from Nekenaan to permanent and or affordable housing. At the end of our fiscal year, March 31st 2019 we had a total 20 families occupying 24 units with a 100% occupancy rate and no arrears.

We have continued to bring improvements to Nekenaan, thanks to the Ontario Trillium Foundation. Thanks to this amazing opportunity, we have been able to repaint all the units, including the common rooms. We have also been able to refurbish all the kitchen cabinets with soft closing doors and drawers. This will extend the life of the cabinetry and will last us for many years to come. Also from this funding came our fantastic addition of the brand new tables, chairs, night tables, and dressers, each unit received to replace our aging furniture. Thank you Ontario Trillium Foundation for allowing us the opportunity to make our building better equipped to help the women we serve.

We also wish to extend our gratitude to the ALFDC HPS Capital Grant. With this grant we were able to improve the gathering space and make it more accessible. The basement washrooms were refreshed with new counters. We also upgraded the accessibility of our front entrance, to improve access.

On our administration side, we continue to update and reorganize our process to make sure that every woman who walks through our doors has more chances of success. Our waiting list has been streamlined to allow a quicker intake process, including interviews, and move-ins. We have added continuous check-ins with clients while they are here to make sure they are supported and we continue to provide resources to optimize the client's success.

Nekenaan's successes and growth will always be reflected best in the lives of the women and children who come to live here. As we continue to grow and change, there will be challenges to face, but, we will become stronger and wiser because of them. I once again look forward to working with our Nekenaan team, and to continue to provide support to the women and children who access our services.
